**MOTION FOR LEAVE TO EXCEED
PAGE LIMITS**

20 Pursuant to this Court’s standing order dated September 22, 2016 (ECF Doc. # 7)
21 and LRCiv 7.2(e), though counsel undersigned, Defendant Andrew Tuohy (“Mr. Tuohy”)
22 respectfully moves the Court for leave to exceed the 17-page limit established by LRCiv
23 7.2(e).

24 Good cause exists for this request because Plaintiff’s operative pleading (the First
25 Amended Complaint filed February 8, 2017; ECF Doc. #11; “FAC”) is exceptionally
26 lengthy; the pleading contains 347 paragraphs of allegations spanning 48 pages supported
27 by nearly 200 pages of exhibits. For the reasons explained in the Motion to Dismiss
28 submitted herewith, Defendant contends that despite its length, the Complaint fails to

1 state any viable claim upon which relief may be granted. However, due to the extremely
2 large number of actual allegations

3 Due to the exceptionally prolix nature of the Complaint, Defendant respectfully
4 submits that good cause exists to grant leave to exceed the 17-page limit by six (6)
5 additional pages.
